

# Call for Nominations



## 2009 Excellence in Mentorship Award

In order to support and recognize outstanding individual achievements in the field of substance abuse mentoring, AMERSA will be presenting the annual *Excellence in Mentorship Award* at the 2009 AMERSA National Conference. The criteria and the nomination procedures for the Excellence in Mentorship Award are summarized below.

We invite you to nominate an individual from any discipline who has provided exceptional mentoring to you, resulting in your increased scholastic achievement and career advancement in the area of substance abuse education or research. Nominations are welcome *from AMERSA members* who are receiving or have received mentorship from such individuals.

To nominate someone for the award, you must complete a one-page form, including your name, the name of the nominee, and a description of how the nominee has assisted in your teaching and/or research achievements and helped to advance your academic career. You may attach abstracts, papers, or other documentary evidence and you must include your curriculum vitae and the nominee's curriculum vitae.

All nominations must be received by **May 1, 2009**. The AMERSA Mentorship Review Committee will review all nominations and present its selection to the Executive Committee for final approval. The nominee must agree to attend the AMERSA national meeting and receive the award in person. This award includes conference registration, a commemorative plaque, and travel expenses to the conference. Nominees will be informed of the Committee's decision by the first week of July.
