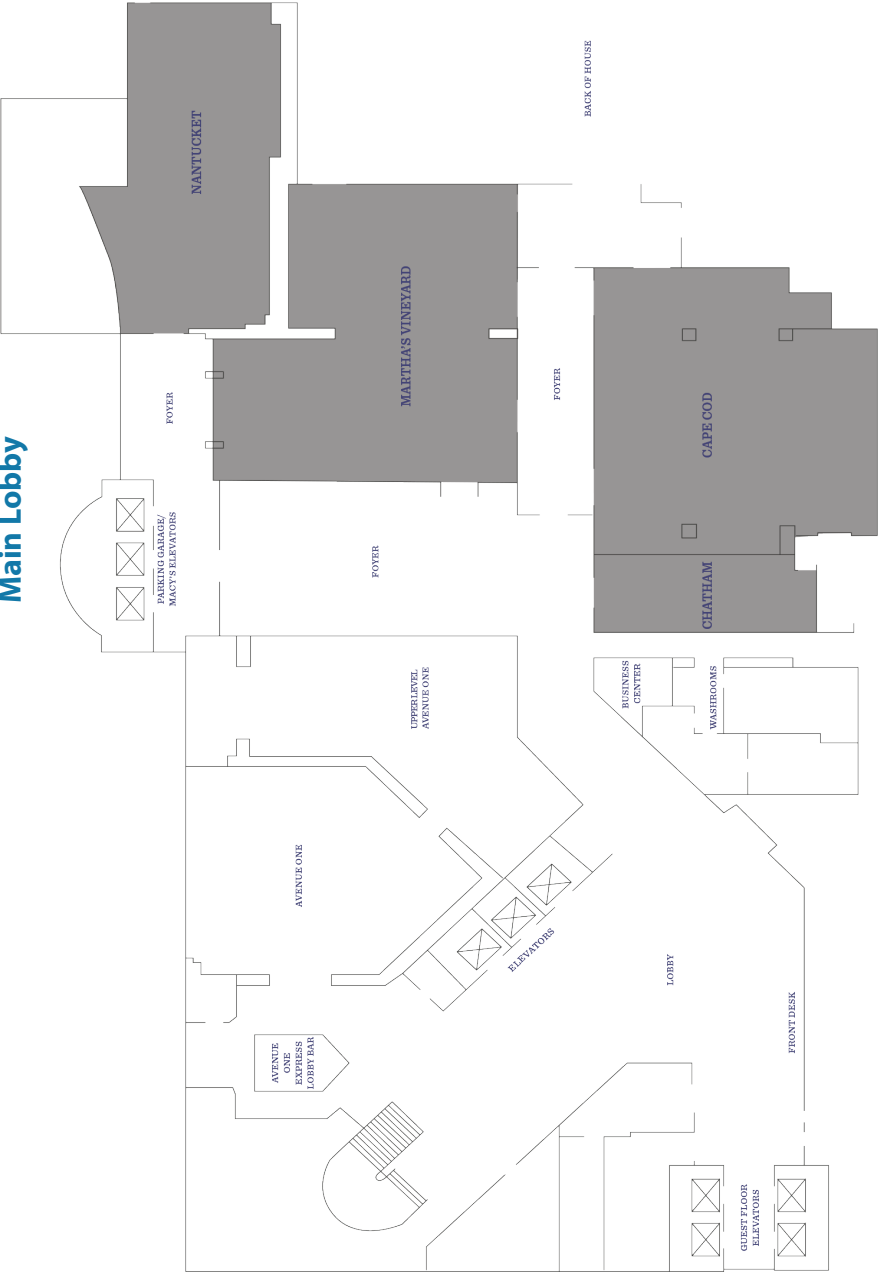

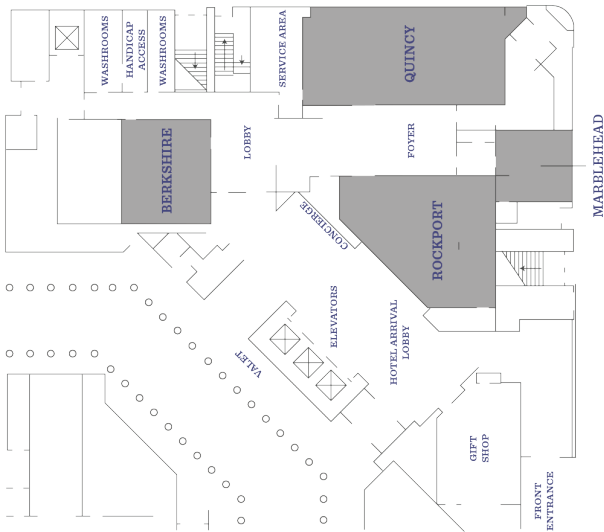

Main Lobby

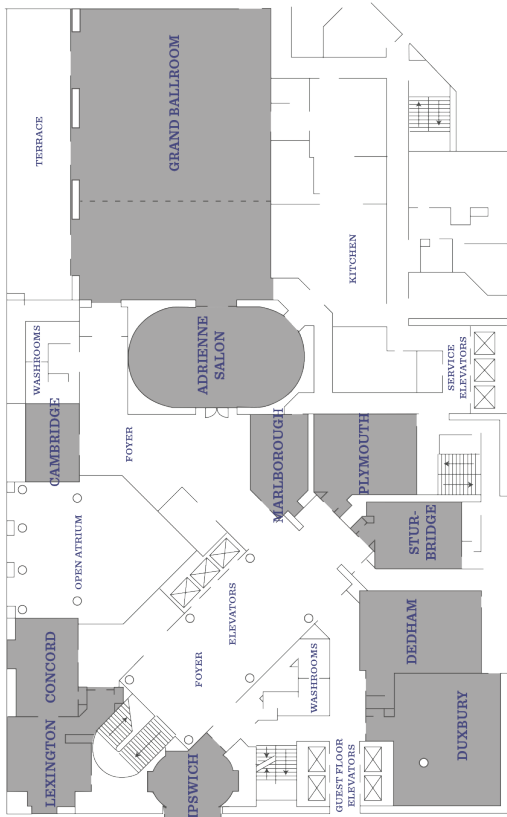


Floor Plan
